(hereinafter referred to as "Client") and Smarty Dog Training (hereinafter known as "Trainer") where group classes, private consultations or lessons, workshops, or other related activities (hereinafter known as "Classes") pertains to the following:

By initialing each section, I confirm that I have read and understand the following:

_____ 1. I verify that Dog is in good health and has not shown clinical signs of any communicable disease within the last 14 days. If Dog contracts a communicable disease during the time Dog is attending Classes, I assume the risks, although small, and accept responsibility for the costs for all treatments. I agree to withhold Dog from Classes until Dog has been free of any signs of communicable disease for at least 48 hours. I agree to hold Trainer harmless from expenses incurred for treatment. I understand that dogs in heat are not permitted in class; however, in that case, I am encouraged to attend without Dog.

_____ 2. I recognize that there are certain inherent risks associated when working with animals, and assume full responsibility for any personal injury to me, my guests, and Dog (hereinafter known as "Attendees"). I further release and discharge Trainer for any injury, loss or damage arising from any Attendee's use of or presence at Trainer's facilities, whether due to any action or inaction by any Attendee's, Trainer's staff members, or any other third party. If Dog causes property damage, or bites or injures any animal, or person (including but not limited to Trainer and Trainer's staff), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred.

_____ 3. In order to establish a safe and healthy environment, Trainer requires proof of current vaccinations for Dog. I certify that Dog has received all core vaccines including Rabies, Distemper, Parvovirus, & Hepatitis vaccinations. If Dog is too young to complete the entire series of inoculations, Dog may not yet be fully protected and I hereby accept any risks of infection. I understand that heartworm, flea, and tick preventatives are recommended however not required for Classes. I understand that Bordetella and Leptospirosis vaccines are recommended however not required for Classes.

_____ 4. I understand and accept that pictures may be taken of Attendees and I hereby release, discharge and agree to hold harmless Trainer from any and all liability relating to such pictures, including publication thereof. I hereby waive any right to inspect or approve any finished product including one or more such pictures. I hereby release Trainer from any and all claims for damages for libel, slander, invasion of privacy or any other claim based on use of the above-described material(s).

_____ 5. I agree to abide by all rules and instructions presented during Classes. I agree to follow Trainer's methods of positive reinforcement. I agree to follow all state, county, and city leash laws and all state, county, and city pet ordinances.

_____ 6. I understand that I am responsible for supervising any minor guests. Since the primary handler of Dog must devote their full attention to class, I will ensure that at least one additional adult will be present to supervise any minor guests. A minor guest may be unsupervised if they are not in the same room as the animals. I understand that a minor may be a primary handler of Dog; however, a handler 16 years of age and younger must have an adult attend the class with said minor.

_____ 7. I understand that only persons who have completed this Dog Training Services Agreement may handle Dog in Classes.

_____ 8. I agree to indemnify and defend Trainer against all claims, cause of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may arise from each Attendee's use of or presence at Trainer's facilities. I have read this consent and understand the inherent risks of allowing groups of dogs to intermingle. I have been encouraged to discuss any concerns I have about those risks and have had my questions answered to my satisfaction.

_____ 9. I acknowledge that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time.

Payment

Payment must be received prior to first class. Please note that sales tax is applied to purchase of Classes. Smarty Dog Training accepts Cash (receipts by request), Check, or Credit Card. For good and valuable consideration, the parties agree as follows:

Services:

Trainer agrees to provide Classes for Client and Dog. The goal is to teach Client how to train and work with Dog. Classes will take place at predetermined location unless otherwise specified. Trainer will make every reasonable effort, based on Trainer's professional opinion, to help Client achieve training and behavior modification goals. Trainer makes no guarantee regarding Dog's performance or behavior as a result of Classes. Client understands that, to achieve training and behavior modification goals, Client and their household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training being given to Dog.

Cancellation Policy: Payment for Classes is non-refundable, and it is Client's responsibility to attend the Classes as scheduled. Classes may be rescheduled upon at least 24 hours advance notice. Refunds will only be given if the Client is no longer in possession of Dog. All Classes must be completed within 180 days from the first group session for which you have registered.

At Trainer's sole election, Trainer's duties hereunder shall terminate if

- (a) in Trainer's sole judgment, Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs;
- (b) Client breaches any term or condition of this Agreement; or
- (c) Client no longer has possession of Dog.

Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect. Refunds will be given only in the case of Client no longer being in possession of Dog.

This Agreement is binding upon Client. This Agreement constitutes the entire agreement between Client and Trainer regarding the matters described above and supersedes all prior discussions, representations, warranties and agreements of the parties. The parties agree that, except as specifically written in this Agreement, no promises, representations or oral understandings have been made. This Agreement may be amended only by a written instrument signed by both parties. No deviation from this agreement, whether by action or inaction, will be considered a waiver of any rights.
